The Milford Community School Use Program is once again offering a SKI PROGRAM for 6<sup>th</sup>, 7<sup>th</sup>, and 8<sup>th</sup> grade students at WACHUSETT MOUNTAIN in Princeton, MA. The program will be held on Sundays for 6 weeks beginning JANUARY 8, 2006.

Students may register for 6 lift tickets only; or 6 lift tickets, plus 6 hours of ski lessons. Equipment rental is also available. Transportation assessment per student is \$45.00.

The bus will leave promptly from the Milford High School front parking lot at 3:30PM and will leave from Wachusett at approximately 8:30PM. All students must ride the bus! As a safety precaution, and in the best interest of you and your child, please make every effort to be at Milford High School to pick up your child when the bus arrives.

Wachusett Mountain has requested that we not reproduce their application, so we are asking your cooperation in completing and signing both applications - one for the Milford Community Program and one for the Wachusett Mountain. **The Wachusett Mountain Application is only available at the Milford Community Program Office.** Please be sure to complete all pertinent areas of the Wachusett application.
